**WARNING OF RISK**

Soccer is intended to challenge and engage the physical, mental and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury. All hazards and dangers cannot be foreseen. Because soccer is a contact sport played with little or no equipment and because it puts great demands on stamina, the very nature of the game of soccer is hazardous and risky. Such risks and dangers include, but are not limited to, acts of kicking, heading and fielding the ball, colliding with other players or stationary objects, being struck by errant balls, running, jumping, stretching, sliding, diving, acts of God, inclement weather, poor officiating, inadequate or defective equipment, failure in supervision or instruction, poor officiating, unsportsmanlike conduct, dangerous or defective playing conditions such as rocks or holes on or off the playing field, seams or tears in the Astroturf, incorrect footwear in poor weather conditions, horseplay, carelessness, and all other circumstances inherent to sport of soccer. In this regard, it is impossible for the Decatur Park District to guarantee absolute safety.
