

# Illini United Youth VOLLEYBALL League

For children in 1st - 6th grades



The goal of the Illini United Youth League is to have fun while teaching the fundamentals of volleyball (passing, serving, setting, spiking). The program, under the direction of Jay McAtee and his team of experienced coaches, has provided a great learning environment for young players. Our youth league uses a slightly smaller court than regulation size, lighter volleyballs and a net height approximately one foot lower than high school. Teams play 4-on-4 to promote movement and being involved.

Each group will practice for 1 1/2 hours (between 8:30 a.m. - 2:30 p.m.) on Saturdays and will be divided based on age and ability. In-house tournaments will also be held at the DISC on Saturdays in 2-hour time slots between 9 a.m. - 3 p.m. Tournament schedule will be emailed out the week of the game (please print email clearly).

There are no tryouts for youth volleyball. The first 120 registrations received with \$130 payment will be accepted. Fee includes uniform, coaches, equipment and facility usage.
