

ORDINANCE NO. 2018-1
AN ORDINANCE FIXING RULES TO BE
OBSERVED AND FEES TO BE CHARGED
FOR THE USE OF GOLF COURSES MANAGED
AND MAINTAINED BY THE DECATUR PARK DISTRICT
AND REPEALING ORDINANCE NO. 2017-1 OF THE
ORDINANCES OF THE DECATUR PARK DISTRICT

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE DECATUR PARK DISTRICT:

SECTION 1. That from and after the passage of the Ordinance, the Ordinance heretofore adopted by the Decatur Park District for the purposes of fixing and determining fees for the use of the several golf courses owned and operated by the Decatur Park District, namely Ordinance No. 2017-1 is hereby repealed. Any other Ordinances or parts of ordinances heretofore adopted by the Decatur Park District, conflicting with this Ordinance, governing the use and fees of the several golf courses owned and operated by the Decatur Park District are hereby repealed.

SECTION 2. From and after the effective date of this Ordinance, the several golf courses owned and operated by the Decatur Park District shall be available to the public for use in playing and engaging in the game of golf and for no other purpose other than those agreed upon by the Executive Director or the Golf Manager and upon such conditions and upon payment of fees for the use thereof as hereinafter provided.

SECTION 3. The 2018 golf season for each course shall be limited to a designated time as follows:

Red Tail Run	March 1 st thru December 2 nd (Weather Permitting)
Hickory Point	March 1 st thru December 2 nd (Weather Permitting)

Winter golf will be played on December 3, 2018 (course to be determined at a later date) thru February 28, 2019 (weather permitting). Each of the said golf courses, namely, Red Tail Run Golf Course and Hickory Point Golf Course and all driving ranges, shall be open and available for usage on such days and at such times as may be fixed and determined by the Executive Director or the Golf Manager. Each golf course greens superintendent is authorized to close any golf course or any part of

such golf course for which he has responsibility at any time that he considers and determines that it is in the best interest of said course or any part thereof.

SECTION 4. The professional or manager on duty at each golf course shall be ---

- A. Responsible to the Executive Director and the Golf Manager.
- B. In charge of the club house, driving range and all golf equipment and supplies which may be owned by the Decatur Park District and maintained for the use of golf players.
- C. Responsible for the collection of the fees for the privilege of using the golf course/driving range as hereinafter provided, and may deny the privileges of playing golf to any person who does not comply with the terms of this Ordinance or who otherwise conducts himself/herself in an unsportsmanlike manner or interferes with the orderly use of such golf course by other persons lawfully entitled to the use thereof.

SECTION 5. Each golf player must register at the applicable professional shop before entering upon play at any of said golf courses. A notice posted near the number 1 tee that the golf course is closed shall constitute notice to all persons that the golf course is closed to public use by official action in accordance with the Ordinance.

SECTION 6. No privately owned, self-propelled, riding vehicle shall be allowed upon any of said golf courses.

SECTION 7. The playing of golf or the practicing of golf shots is prohibited on property owned by the Decatur Park District except upon the established courses operated by the Decatur Park District, when said golf facilities are open for public use.

SECTION 8. From and after the effective date of this Ordinance fees shall be charged for the privilege of playing upon the several golf courses hereinafter named in accordance with the following schedule fee:

(*) Junior season passholders can golf without further charges anytime on weekdays as well as after 1:00 pm on weekends and Holidays. On weekends and holidays before 1:00 pm, junior passholders will pay the daily fee of \$16.00.

(b) Twenty-five percent (25%) off the All Course (7 Day) pass.

(c) Twenty-five percent (25%) off the All Course (5 Day) pass.

SPECIAL RATES

Red Tail Run & Hickory Point Monday through Friday after 12:00 p.m. patrons may play 18 holes for \$17.50 at Red Tail Run and Hickory Point.

Red Tail Run & Hickory Point after 6:00 p.m. an \$8.00 walking all you can play rate is available at all courses and the cart fee is \$12.00.

Red Tail Run & Hickory Point after 2:00 pm on Weekends and Holidays the rate will be \$30.50 total (\$14.50 green fee/\$16.00 cart fee).

Golf Card**

Red Tail Run and Hickory Point **\$15.00 per round**

**Golf Card will be honored at Red Tail Run and Hickory Point Monday thru Friday at no restricted times except during tournaments and outings. Weekends and holidays are restricted to after 11:00 a.m. The Golf Card rules will apply and the appropriate Capital Improvement fees will be charged.

An 18 hole greens fee is good for all day.

Season Pass Holder

Red Tail Run and Hickory Point **\$1.50 per round**

*Option for Season Pass Holders to pay in advance (\$1.50 x rounds played in 2017) or \$1.50 x 70 rounds if not a pass holder in 2017 (\$105.00).

For the purpose of the Ordinance, persons 13-18 years of age in the 2018 calendar year shall be deemed "JUNIORS" and persons 65 years of age or older during the 2018 calendar year shall be deemed "SENIORS".

"HOLIDAYS" shall include New Year's Day, Martin Luther King Jr's Birthday, Presidents Day, Good Friday, Memorial Day, Independence Day, Labor Day, Veterans Day, Thanksgiving Day and Friday after Thanksgiving, and Christmas Day.

When any such holiday occurs on a Saturday, the preceding Friday shall be declared a holiday; and when any such holiday occurs on Sunday, the following Monday shall be declared a holiday.

"SEASONS" shall mean all of that part of any calendar year as listed in Section 3 of the 2018-1 Ordinance.

SECTION 9. Participants in the golf athletic programs of the school districts operating within The Decatur Park District may be permitted to use the several golf courses hereinbefore named upon the following terms and conditions:

- A. An authorized representative of any school electing to use golf courses pursuant to this Ordinance shall file with the Executive Director or the Golf Manager in duplicate, the names of all individuals participating in the school's golf athletic program and only such course or courses as the Executive Director or the Golf Manager shall determine shall be made available for usage to school districts operating within the Decatur Park District.
- B. Practice, other than the playing of regular rounds of golf, will be permitted, only when the instructor or coach of the school, class or team is present.
- C. Not more than two (2) school districts may regularly practice at any one golf course simultaneously with a maximum of (3) times per team (12 players) per day. The exceptions being; matches or tournaments.
- D. Schools and colleges which operate outside the Decatur Park District and maintain a golf athletic program may be permitted to use the Decatur Park District golf courses upon advance payment of fees as determined by the Executive Director and the Golf Manager. This fee for the 2018 golf season shall be \$760.00.
- E. Millikin University, St. Teresa, LSA, and all public schools operating within the Decatur Park District and maintaining a golf athletic program may be permitted to use Decatur Park District golf courses without charge during their respective seasons.

SECTION 10. Golf Course Parking Restrictions will be enforced.

SECTION 11. Any person violating any of the provisions herein shall be subject to a fine of not more than One Hundred Dollars (\$100.00).

SECTION 12. The invalidity of any portion of the Ordinance shall not invalidate the remaining portions of this Ordinance.

SECTION 13. This Ordinance shall be in full force and effect as of November 1, 2017.


